Rules of Competition

I. Preliminaries

1. Preliminary judging will be by audiocassette to be sent to auditions chairman.
2. Cassettes must be postmarked by *October 1, 2006*.
3. Age Limits: 18 – 38 (Entrants must have reached their 18th birthday, and not their 39th by *March 1, 2007*).
4. There must be NO verbal identification of the team on the cassette. Such identification will disqualify the tapes.

II. Finals

1. Final auditions will be live at Converse College in Spartanburg SC in the spring of 2007 (date to be announced).
2. Pianos will be available for rehearsal beginning at 1:00 p.m. on Friday before the competition.
3. All entrants will receive official notification of the results of the preliminary judging by *December 1, 2006*.
4. Finalists may provide their own orchestral accompanists for the concerti; or, upon request, a professional accompanist will be provided.
5. Contestants not bringing their accompanist for the concerti must send a piano reduction of the orchestral part (for a 3rd piano) to the auditions chairman upon acceptance in the finals.
6. The finals for those teams providing their own accompanists will be heard at the beginning of the competition.
7. Winners will be announced and prizes awarded at the close of the competition.
8. Decisions of the judges will be final.

APPLICATIONS:

1. Each entrant must submit an application.
2. All applications must be accompanied by:
 - An entrance fee of \$50 per duo-team
 - Proof of American citizenship (copy of birth certificate OR naturalization papers of **each** entrant)
 - Statement that entrants are not under professional management as a team
 - A small photograph of each entrant.
3. *Deadline: All completed applications and audiocassettes must be postmarked by October 1, 2006.*
